By submitting an application form to join the mentoring programme, I agree to abide by the regulations detailed in this document.

# 1. Application Screening and Matching Process:

- 1.1. I understand that *Ektaa's team* will screen my application form and, if further information is required, I will be contacted to arrange a phone call conversation with a member of the team.
- 1.2. I understand that *Ektaa's team* will use the information I have provided in my application form to match me to the most suitable mentee(s).
- 1.3. I understand that I may be matched to more than one mentee, if I have indicated that I can work with more than one on my application form.

#### 2. As a mentor:

- 2.1. I agree to attend the mentoring sessions on the agreed days and times with my mentee(s), and in the event that I am unable to attend I will contact my mentee(s) as soon as possible.
- 2.2. I understand that I must act respectfully towards my mentee(s), and thus I agree to try my best to respond to any emails/ phone calls from my mentee within a 5 working day period.
- 2.4. I understand that my mentee(s) will have identified different areas of personal and professional development and I may be supporting them in a range of areas which could include, and is not limited to:
  - a. Providing an insight into work and career pathways
  - b. Providing information and guidance on different career options or further study
  - c. Reviewing CVs, cover letters or application forms
  - d. Preparing for interviews
  - e. Searching for work experience/ internships or jobs opportunities
  - f. Developing skills such as networking, communication, and public speaking
- 2.5 I understand that I should not work beyond the bounds of my capability, experience and expertise to the point where I do not feel confident in providing my mentee(s) with proper support. Where this is the case, I understand that I should refer my mentee(s) to *Ektaa's team*.



- 2.6 I understand and agree to not use any ideas, products or materials that my mentee(s) has, or may develop, to further my business or financial interests; and maintain the confidentiality of all ideas, products or materials that have been entrusted to me by my mentee(s).
- 2.7 While I understand that most mentoring relationships progress without any problems, I agree to advise *Ektaa's team* (via email at equalrepresentationacademia@gmail.com) at the earliest opportunity of any difficulties encountered during the mentoring relationship that cannot be resolved with my mentee(s).
- 2.8. I understand that *Ektaa's team* will fully investigate any problems I report about my mentoring relationship and will liaise between myself and my mentee to resolve any issues; I will be kept informed about the outcome of this process.

# 3. After the Mentoring Cycle:
